WHEREAS, on January 5, 2023, Jacob G., a minor, by and through his Guardian ad Litem Amber Gibb, filed suit against the City of San Diego. The suit is entitled *Jacob G. v. City of San Diego, et al.*, San Diego Superior Court Case No. 37-2023-00003981-CU-PO-CTL (Litigation); and

WHEREAS, in Closed Session on May 13, 2024, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7, 8, and 9; Nays, None; authorized settlement of the Litigation for an amount consistent with the amounts set forth below and pursuant to such other terms more fully set forth in the settlement agreement; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the City Council:

1. Authorizes the Mayor or his designee to pay the sum of \$250,000.00 from the Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, against City of San Diego, its agents and employees, arising from the Litigation;

2. Authorizes the Chief Financial Officer to expend an amount not to exceed \$250,000.00 from the Public Liability Fund No. 720045 for the purpose of settling this Litigation.
