A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN
REBECCA WILHITE AND THE CITY OF SAN DIEGO.

WHEREAS, on August 23, 2022, Rebecca Wilhite filed suit against the City of San Diego alleging personal injuries arising from a trip and fall incident that occurred on May 23, 2021, at or near the Naval Training Center Park, San Diego, California. The suit is entitled *Rebecca Wilhite v. City of San Diego*, San Diego Superior Court Case No. 37-2022-00033987-CU-PO-CTL (Litigation); and

WHEREAS, in closed session on June 10, 2024, the City Council by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7, and 9; Nays, None; and Absent, District 8; approved the settlement of the Litigation against the City of San Diego for an amount consistent with the amounts set forth below. NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, that the Council:

1) Authorizes the Mayor or his designee to pay the sum of \$150,000.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against the City of San Diego, its agents and employees, arising from the Litigation; and

2) Authorizes the Chief Financial Officer to expend an amount not to exceed

\$150,000.00 from Public Liability Fund No. 720045, for the purpose of settling this Litigation.
