
A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DESIGNATING THE 2500 BLOCK OF SAN DIEGO AVENUE, LOCATED IN THE OLD TOWN COMMUNITY, TO BE KNOWN AS DIANE POWERS WAY.
