A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN
DEBORAH GATTO AND THE CITY OF SAN DIEGO

WHEREAS, on August 19, 2022, Plaintiff Deborah Gatto filed suit against the City of San Diego (City), alleging personal injuries from a trip and fall accident that occurred on June 24, 2021, when she claims she tripped on a raised portion of sidewalk. Plaintiff's lawsuit is entitled *Deborah Gatto v. City of San Diego*, San Diego Superior Court Case No. 37-2022-00009498-CU-PO-CTL (Litigation); and

WHEREAS, in Closed Session on June 24, 2024, the City Council, by the following votes: Yeas, Districts 1, 3, 4, 6, 7, 8, 9; Nays, District 5; and Absent, District 2, approved the settlement of the Litigation for an amount consistent with the amounts set forth; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego that the Council authorizes:

1. The sum of \$72,500.00 to be paid from Public Liability Fund No. 720045 in settlement of each and every claim for damages, interest, costs and fees of any type, including attorney fees, against the City, its agents and employees, arising from the Litigation.

2. Authorizes the Chief Financial Officer to expend an amount not to exceed \$72,500.00 from Public Liability Fund No. 720045, for the purpose of settling this Litigation.
