A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN
SAN DIEGO GAS & ELECTRIC AND THE CITY OF SAN
DIEGO.

WHEREAS, on July 11, 2022, San Diego Gas & Electric (SDG&E) filed a claim against
the City of San Diego alleging property damage arising from excavation at Hornblend Street; and

WHEREAS, in Closed Session on June 24, 2024, the City Council, by the following
votes: Yeas, Districts 1, 3, 4, 6, 7, 8, and 9; Nays, District 5; and Absent, District 2, approved
the Settlement for an amount consistent with the amounts set forth below;


NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Council:

1. Authorizes the Mayor or his designee to pay the sum of \$73,981.43 from Muni
Sewer Revenue Fund No. 700000, in settlement of each and every claim for damages, interest,
costs, and fees of any type, including attorney fees, against City of San Diego, its agents and
employees, arising from the claim for property damage filed by SDG&E.

2. Authorizes the Chief Financial Officer to expend \$73,981.43 from Muni Sewer Revenue Fund No. 700000, for the purpose of settling this claim.
