A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO CONFIRMING AN APPOINTMENT AND REAPPOINTMENT TO THE CITIZENS EQUAL OPPORTUNITY COMMISSION.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

- A. San Diego Municipal Code section 26.16 (Municipal Code) established the Citizens Equal Opportunity Commission (Commission).
- B. The Municipal Code provides that the Commission: monitor and evaluate the City of San Diego's Equal Opportunity Program; advise the Mayor, Council of the City of San Diego (Council), Civil Service Commission, and other appropriate agencies of the City of San Diego (City); submit written annual reports for review by the Council's Committee on Budget and Government Efficiency and the Council; assist in recruiting competent minorities, women, and disabled persons to compete for available City positions; and promote the City as an Equal Opportunity Employer of individuals and firms desiring to contract with the City.
- C. The Commission shall consist of 11 members appointed by the Mayor and confirmed by the Council.
- D. The Commission shall include nine representatives who actively advocate for or represent each of the following groups: Latino, African-American, Native Hawaiian or other Pacific Islanders, Native American, Asians, Disabled, Lesbian/Gay/Bisexual/Transgender (LGBT), Women, and Disabled Veterans. The remaining two members of the Commission shall be appointed from the City at large.

- E. Members shall serve two-year terms and each member shall serve until a successor is duly appointed and confirmed All terms must have expiration dates of January 1.
- F. The Mayor now seeks confirmation of an appointment and reappointment to the Commission.
- G. The Office of the City Attorney prepared this Resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete and accurate.
