

RESOLUTION NUMBER R- **315755**DATE OF FINAL PASSAGE **SEP 16 2024**A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO CONFIRMING AN APPOINTMENT TO
THE BOARD OF LIBRARY COMMISSIONERS.

WHEREAS, the Board of Library Commissioners (Board) is established in San Diego Municipal Code section 26.0301 to provide the City of San Diego's (City) library system with the benefit of the advice of interested citizens representative of the community; and

WHEREAS, the Board considers all policy matters relating to the development and operation of the City's library system, and is advisory to the Mayor and the Council of the City of San Diego on all questions of library policy; and

WHEREAS, the Board consists of eleven members who serve two-year terms and until their successors are duly appointed and qualified; and

WHEREAS, the Mayor shall appoint nine members, one to represent each council district, based on nominations provided by each Councilmember; and

WHEREAS, the tenth member shall be an at-large member appointed by the Mayor; and

WHEREAS, during the time the San Diego Unified School District (School District) leases spaces at the Central Library for a school or school related purpose, and as required by the terms of the lease, the eleventh member shall be an official representative of the School District; and

WHEREAS, the Mayor shall appoint the School District member from a list of nominations submitted by the School District; and

WHEREAS, the Council of the City of San Diego shall confirm all eleven Board members; and

WHEREAS, Board member terms expire on March 1, and not more than six members' terms shall expire in any year; and

WHEREAS, during March of each year, the Mayor may designate one member as Chairperson; however, in the absence of such designation, the Board shall, on or after April 15, select the Chairperson from among its members; and


