A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN
TIFFANY VINSON AND THE CITY OF SAN DIEGO.

RECITALS

The Council of the City of San Diego adopts this Resolution based on the following:

A. On February 13, 2020, Tiffany Vinson filed a lawsuit against the City of San Diego for the damages that occurred to Tiffany Vinson from July 3, 2019, through September 16, 2019. The lawsuit is entitled *Tiffany Vinson v. the City of San Diego*, San Diego Superior Court No: 37-2020-00008295-CU-OE-CTL (Litigation).

B. In Closed Session on July 15, 2024, the San Diego City Council, by the following votes: Yeas, District 1, 2, 3, 4, 5, 6, 7, 8, and 9; Nays: None; Absent: None, approved the settlement of the Litigation for an amount consistent with the amount set forth below.

ACTION ITEMS

Based on the Recitals set forth above, the Council resolves as follows:

1. The Mayor or his designee is authorized to pay the sum of \$60,000.00 to Tiffany Vinson from Public Liability Fund No. 720045 in settlement of each and every claim for damages, interest, costs and fees of any type, including attorney fees, against the City, its agents and employees, arising from the Litigation.

2. The Chief Financial Officer is authorized to appropriate and to expend an amount not to exceed \$60,000.00 from Public Liability Fund No. 720045, for the purpose of settling this Litigation.
