- B. In Closed Session on July 15, 2024, the San Diego City Council, by the following votes: Yeas, District 1, 2, 3, 4, 5, 6, 7, 8, and 9; Nays: None; Absent: None, approved the settlement of the Litigation for an amount consistent with the amount set forth below.
