A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTLEMENT BETWEEN DENICE SIMMONS, INDIVIDUALLY AND AS PERSONAL REPRESENTATIVE OF THE ESTATE OF MARC WOOLF AND THE CITY OF SAN DIEGO

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

- A. On May 4, 2022, Marc Woolf filed suit against the City of San Diego alleging personal injuries arising from a traffic collision on May 5, 2021, at or near the 2300 block of Congress Street in Old Town, San Diego. Following Marc Woolf's death, Marc Woolf's daughter, Denice Simmons, individually and as personal representative of the estate of Marc Woolf, amended the suit. The lawsuit is entitled *Denice Simmons, Individually and as Personal Representative of the Estate of Marc Woolf v. City of San Diego, et al.*, San Diego Superior Court Case No. 37-2022-00016872-CU-PO-CTL (Litigation).
- B. In closed session on September 9, 2024, the City Council, by the following votes: Yeas, Districts 1, 3, 4, 5, 6, 7, 8, and 9; Nays, None; and Absent, District 2, approved the settlement of the Litigation for an amount consistent with the amounts set forth below.

ACTION ITEMS

Be it resolved by the Council of the City of San Diego:

1. A resolution authorizing the Mayor or his designee to pay the sum of \$7,000,000.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against the City, its agents, and employees, arising from the Litigation.
