A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO CONFIRMING AN APPOINTMENT TO THE
PLANNING COMMISSION.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

- A. The Planning Commission (Commission) is established in San Diego Charter section 41(c).
- B. The Commission conducts hearings on all special use permits, all re-zonings, all community plans, and the General Plan and considers land use ordinances and other improvements as the Council may, by ordinance, determine.
- C. The Commission consists of seven members appointed by the Mayor, subject to Council confirmation.
- D. Members of the Commission serve four-year terms and until their successors are appointed, confirmed, and qualified.
- E. Appointments to the Commission are to be made so that not more than three members are appointed in any one year.
- F. The Office of the City Attorney prepared this Resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete and accurate.
