- A. The Planning Commission (Commission) is established in San Diego Charter section 41(c).

- C. The Commission consists of seven members appointed by the Mayor, subject to Council confirmation.
- D. Members of the Commission serve four-year terms and until their successors are appointed, confirmed, and qualified.
- E. Appointments to the Commission are to be made so that not more than three members are appointed in any one year.
- F. The Office of the City Attorney prepared this Resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete and accurate.
