RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

- A. Plaintiffs Jeffrey Allen Welsh and Christina Anne Flynn filed suit against the City of San Diego alleging property damage due to multiple flooding events from November 2019 through December 2021. The suit is entitled *Jeffrey Allen Welsh*, et al. v. City of San Diego, San Diego Superior Court Case No. 37-2022-00040747-CU-EI-CTL (Litigation).
- B. In closed session on September 9, 2024, the San Diego City Council, by the following votes: Yeas, Districts 1, 3, 4, 5, 6, 7, 8, and 9; Nays, None; Absent District 2, approved the settlement of the Litigation for an amount consistent with the amounts set forth below and pursuant to such other terms more fully set forth in the Settlement Agreement.

Be it resolved by the Council of the City of San Diego:

1. The Mayor or his designee is authorized to pay \$300,000.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents, and employees, arising from the Litigation.
