RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

- A. On February 10, 2023, Laura Ann Brickley filed suit against the City of San Diego alleging personal injuries arising from a trip and fall incident that occurred on October 2, 2022, on an alleged asphalt and dirt section of a sidewalk at or about 5800 Regents Road near Pennant Way, San Diego. The lawsuit is entitled *Laura Ann Brickley v City of San Diego, et al.*, San Diego Superior Court Case No. 37-2023-00005997-CU-PO-CTL (Litigation).
- B. In closed session on September 9, 2024, the City Council, by the following votes: Yeas, Districts 1, 3, 4, 6, 7, 8, and 9; Nays, District 5; and Absent, District 2; approved the settlement of the Litigation for an amount consistent with the amounts set forth below.
