A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN
LAURA ANN BRICKLEY AND THE CITY OF SAN DIEGO

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. On February 10, 2023, Laura Ann Brickley filed suit against the City of San Diego alleging personal injuries arising from a trip and fall incident that occurred on October 2, 2022, on an alleged asphalt and dirt section of a sidewalk at or about 5800 Regents Road near Pennant Way, San Diego. The lawsuit is entitled *Laura Ann Brickley v City of San Diego, et al.*, San Diego Superior Court Case No. 37-2023-00005997-CU-PO-CTL (Litigation).

B. In closed session on September 9, 2024, the City Council, by the following votes: Yeas, Districts 1, 3, 4, 6, 7, 8, and 9; Nays, District 5; and Absent, District 2; approved the settlement of the Litigation for an amount consistent with the amounts set forth below.

ACTION ITEMS

Based on the Recitals set forth above, the Council resolves as follows:

1. The Mayor, or his designee, is authorized to pay the sum of \$85,000.00 from Public Liability Fund No. 720045 in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against the City, its agents, and employees, arising from the Litigation.

2. The Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$85,000.00 from Public Liability Fund No. 720045, for the purpose of settling this Litigation.
