RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

- A. On June 15, 2023, Lillian Smith filed suit against the City of San Diego alleging personal injuries arising from a trip and fall incident that occurred on June 13, 2022, on a sidewalk at or near 3076 Imperial Avenue in San Diego. The lawsuit is entitled *Lillian Smith v. City of San Diego, et al.*, San Diego Superior Court Case No. 37-2023-00025537 CU-PO-CTL (Litigation).
- B. In closed session on September 9, 2024, the City Council, by the following votes: Yeas, Districts 1, 3, 4, 5, 6, 7, 8, and 9; Nays, None; and Absent, District 2; approved the settlement of the Litigation for an amount consistent with the amounts set forth below.

ACTION ITEMS

Based on the Recitals set forth above, the Council resolves as follows:

1. Authorizes the Mayor or his designee to pay the sum of \$145,000.00 from Public Liability Fund No. 720045 in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against the City, its agents, and employees, arising from the Litigation.

2. Authorizes the Chief Financial Offi	cer to appropriate and expend an amount not
to exceed \$145,000.00 from Public Liability Fund	No. 720045 for the purpose of settling this
Litigation.
