A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING A CODE OF CONDUCT FOR
BOARDS AND COMMISSIONS.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. By San Diego Ordinance O-21003 (Oct. 26, 2018), the Office of Boards and Commissions was established as a City department to assist the Mayor and Council with the board appointment process, provide administrative support to the City's volunteer bodies, and implement recommendations included in the City Auditor's Performance Audit of the City's Management of its Advisory Boards issued in June 2017.

B. Since the creation of the Office of Boards and Commissions, members of the City's boards and commissioners have been without guidance on conducting themselves as representatives of the City of San Diego.

C. The proposed Code of Conduct is designed to set forth the manner in which appointed members should treat one another, elected officials, City staff, constituents, and others with whom they come into contact while representing the City in their official capacity.

D. The Code of Conduct will help ensure that members of the City's boards and commissions act in an integral manner, will promote professionalism, and outline appropriate behavior and respect for others.

E. The Code of Conduct will be self-enforcing.


F. The Office of the City Attorney prepared this Resolution based on the information provided by City staff, with the understanding that this information is complete and accurate.

Be it resolved by the Council of the City of San Diego:


The City of San Diego Code of Conduct for Boards and Commissions, on file in the Office of Boards and Commissions, is approved.


