A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTLEMENT BETWEEN PLAINTIFF JOAN SAVARESE AND CITY OF SAN DIEGO

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

- A. On March 30, 2022, Plaintiff Joan Savarese filed suit against the City of San Diego, alleging personal injuries arising from a trip and fall accident which occurred on June 27, 2021. The suit is entitled *Joan Savarese v. City of San Diego*, San Diego Superior Court Case No. 37-2022-00012275-CU-PO-CTL (Litigation).
- B. In closed session on September 9, 2024, the City Council, by the following votes: Yeas, Districts 1, 3, 4, 5, 6, 7, 8, and 9; Nays, none; Absent, 2, approved the settlement of the Litigation for an amount consistent with the amounts set forth below and under such other terms more fully set forth in the Settlement Agreement.

ACTION ITEMS

Be it resolved by the Council of the City of San Diego:

1. Authorizes the Mayor or his designee to pay the sum of \$75,000.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents, employees, and contractors arising from the Litigation.

2.	Authorizes the Chief Financial (Officer to appropriate and expend an amount not
