A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTLEMENT OF ELIZABETH MURPHY AND THE CITY OF SAN DIEGO

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

- A. On February 23, 2023, Elizabeth Murphy filed suit against the City of San Diego alleging personal injuries arising from a trip and fall incident that occurred on October 28, 2021, on an asphalt uplift in the street in front of 2250 Froude Street. The lawsuit is entitled *Elizabeth Murphy v. City of San Diego*, San Diego Superior Court No. 37-2023-00007718-CU-PO-CTL (Litigation).
- B. In closed session on September 30, 2024, the City Council, by the following votes: Yeas, Districts 3, 4, 5, 6, 8, and 9; Nays, None; and Absent, Districts 1, 2, and 7, approved the settlement of the Litigation for an amount consistent with the amounts set forth below.

ACTION ITEMS

Be it resolved by the Council of the City of San Diego:

1. Authorizes the Mayor or his designee to pay the sum of \$115,000.00 from Public Liability Fund No. 720045 in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against the City, its agents, and employees, arising from the Litigation.
