A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN
MARY GARLAND AND CITY OF SAN DIEGO

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. On May 4, 2023, Plaintiff Mary Garland filed suit against the City of San Diego, alleging personal injuries arising from a bicycle accident which occurred on July 4, 2022. The suit is entitled *Mary Garland v. City of San Diego*, San Diego Superior Court Case No. 37-2023-00018361-CU-PO-CTL (Litigation).

B. In closed session on September 30, 2024, the City Council, by the following votes: Yeas, Districts 3, 4, 5, 6, 8, and 9; Nays, None; and Absent, Districts 1, 2, and 7, approved the settlement of the Litigation for an amount consistent with the amounts set forth below.


ACTION ITEMS

Be it resolved by the Council of the City of San Diego:

1. Authorizes the Mayor or his designee to pay the sum of \$100,000.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against the City of San Diego, its agents, employees, and contractors arising from the Litigation.

2. Authorizes the Chief Financial Officer to appropriate and expend an amount not to exceed \$100,000.00 from Public Liability Fund No. 720045, for the purpose of settling the Litigation.
