A RESOLUTION OF THE COUNCIL OF THE CITY
OF SAN DIEGO CONFIRMING REAPPOINTMENTS TO THE
SAN DIEGO UNIFIED PORT DISTRICT BOARD OF
COMMISSIONERS.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:


- A. The Council has the power to appoint commissioners to the San Diego Unified Port District Board of Commissioners (Port Commission) under the San Diego Unified Port District Act (Port Act).
- B. Council Policy No. 000-13 outlines the appointment process for boards and commissions.
- C. In 2022, the Council appointed Danielle Moore to the Port Commission for a term expiring on January 2, 2025.
- D. In 2023, the Council appointed Sid Voorakkara to the Port Commission for a term expiring on January 2, 2025.
- E. The Council now considers confirmation of the reappointments of Danielle Moore and Sid Voorakkara to the Port Commission.
- F. The Office of the City Attorney prepared this Resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete and accurate.
- G. The reappointments of Port Commissioners are in the sole discretion of the Council under the Port Act and are therefore not subject to veto.

ACTION ITEMS

Be it resolved by the Council of the City of San Diego:

1. That Danielle Moore and Sid Voorakkara are reappointed to the San Diego Unified Port District Board of Commissioners for terms beginning January 3, 2025, and ending January 2, 2029.
