A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO EXCUSING COUNCILMEMBER CAMPBELL'S ABSENCES FROM COUNCIL AND COMMITTEE MEETINGS.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. Councilmember Jennifer Campbell was unable to attend Council meetings on May 8, 2024, June 24, 2024, and July 30, 2024, due to personal reasons. Additionally, Councilmember Campbell could not attend Council and Committee meetings during September and October 2024 due to medical leave.

B. Pursuant to San Diego Charter section 12(e), the Council may excuse a Councilmember's absences from scheduled Council and Committee meetings.

C. The Office of the City Attorney prepared this Resolution based on the information provided by City staff with the understanding that this information is complete and accurate.

D. Under San Diego Charter section 280(a)(1), this Resolution is not subject to veto by the Mayor because this matter is exclusively within the Council's purview and does not affect the administrative service of the City under the Mayor's control.

4. Councilmember Jennifer Campbell is excused from the Environment Committee meetings held on September 12, 2024, and October 10, 2024.

5. Councilmember Jennifer Campbell is excused from the Public Safety Committee meetings held on September 18, 2024, and October 16, 2024.
