A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO ESTABLISHING A PARKING CITATION FINE
FOR VIOLATIONS OF CALIFORNIA VEHICLE CODE
SECTION 22500(n).

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

- A. Assembly Bill 413 (AB 413) was approved by the California Legislature in September 2023 and signed into law by Governor Gavin Newsom on October 10, 2023.
- B. AB 413 is reflected in California Vehicle Code (CVC) section 22500(n) and prohibits stopping or parking a vehicle within 20 feet of any marked or unmarked crosswalk, or 15 feet of any crosswalk where a curb extension is present, regardless of whether the curb is painted red.
- C. This new law seeks to improve visibility for both drivers and pedestrians by keeping a clear zone of specified distance on the approach side of intersections. This improved visibility has become known as “daylighting.”
- D. Although AB 413 is currently in effect, local agencies may only issue warnings until January 1, 2025, unless the violation occurs in an area with a red curb or posted signs.
- E. On January 1, 2025, the City of San Diego (City) will begin issuing citations for violations of CVC section 22500(n) and, therefore, seeks Council approval to establish a fine amount of \$65, in additional to the State-mandated surcharge of \$12.50 for all City issued parking fines, for a total fine of \$77.50.
- F. The Office of the City Attorney prepared this Resolution based on the information provided by City staff with the understanding that this information is complete and accurate.

ACTION ITEMS

Be it resolved by the Council of the City of San Diego:

1. A City fine for a violation of California Vehicle Code section 22500(n) is established in an amount of \$65, which amount will be in addition to the State-mandated surcharge of \$12.50 for the same violation.
2. The Department of Finance is hereby directed to amend the current Rate Book to include the fees described above and make them available to the public on the City Clerk's public website.
