A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN
PAUL HILLER AND CITY OF SAN DIEGO

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. On April 21, 2023, Paul Hiller filed suit against the City of San Diego alleging personal injuries arising from a trip and fall incident that occurred on August 27, 2022, on a sidewalk adjacent to 3914 Gresham Street, in Pacific Beach. The lawsuit is entitled *Paul Hiller v. City of San Diego, et al.*, San Diego Superior Court Case No. 37-2023-00016879-CU-PO-CTL (Litigation).

B. In closed session on October 28, 2024, the City Council, by the following votes: Yeas, Districts 1, 3, 4, 5, 6, 7, 8, and 9; Nays, None; and Absent, District 2, approved the settlement of the Litigation for an amount consistent with the amounts set forth below.


ACTION ITEMS

1. The Mayor or his designee is authorized to pay the sum of \$250,000.00 from Public Liability Fund No. 720045 in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against the City, its agents, and employees, arising from the Litigation.

2. The Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$250,000.00 from Public Liability Fund No. 720045, for the purpose of settling this Litigation.
