DATE OF FINAL PASSAGE DEC 10 2024

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO SELECTING A COUNCIL PRESIDENT.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. San Diego Charter section 270(d) provides that the Council of the City of San Diego (Council) shall have the right to determine its own rules and order of business, including a process for selecting a presiding officer who shall have responsibility for chairing Council meetings and managing the docket process.

B. Rule 4.2 of the Rules of the Council, San Diego Municipal Code section 22.0101, provides that, in even-numbered years, at the first Council meeting held on or after the tenth day in December, the Council shall select a Council President from one of its members by majority vote, to serve for a term of one year or until a successor is selected and qualified, whichever is later.

C. It is now necessary for the Council to select one of its members to serve as Council President.

D. The Office of the City Attorney prepared this Resolution based on the information provided by City staff, with the understanding that this information is complete and accurate.

E. Under San Diego Charter section 280(a)(1), this Resolution is not subject to veto by the Mayor because this matter is exclusively within the Council's purview and does not affect the administrative service of the City under the Mayor's control.

ACTION ITEMS

Be it resolved by the Council of the City of San Diego:

After a full discussion and deliberation by the Council, Councilmember Joe LaCava is selected as Council President to serve a one-year term commencing on December 10, 2024, and until a successor is selected and qualified.
