RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

- A. The Council may excuse a councilmember from attending a scheduled Council meeting or Council committee meeting.
- B. The Office of the City Attorney prepared this Resolution based on the information provided by City staff with the understanding that this information is complete and accurate.
- C. Under San Diego Charter section 280(a)(1), this Resolution is not subject to veto by the Mayor because this matter is exclusively within the Council's purview and does not affect the administrative service of the City under the Mayor's control.


ACTION ITEMS
