A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO CONFIRMING APPOINTMENTS OF COUNCILMEMBERS TO STANDING COMMITTEES FOR CALENDAR YEAR 2025.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. Rule 6.1 of the Rules of the Council, San Diego Municipal Code section 22.0101, provides for specific standing committees of the Council.

B. Rule 6.2.1 provides that no later than the second Council meeting in January of each year, the Council President shall nominate the committee chair, vice chair, and committee members for each committee, subject to confirmation by a majority vote of the Council.

C. Council President Joe LaCava submitted nominations for the committee chairs, vice chairs, and committee members for the standing committees of the Council for calendar year 2025, and now seeks Council confirmation of the appointments.

D. The additional appointments of Councilmembers to serve on the City of San Diego's Audit Committee, which is governed by the San Diego Charter, will be considered by the Council in a separate action and is not included in this Resolution.

E. The Office of the City Attorney prepared this Resolution based on the information provided by City staff, with the understanding that this information is complete and accurate.

G. Under San Diego Charter section 280(a)(1), this Resolution is not subject to veto by the Mayor because this matter is exclusively within the purview of the Council and does not affect the administrative service of the City under the control of the Mayor.

ACTION ITEMS

Be it resolved by the Council of the City of San Diego:

1. The Council confirms the Community and Neighborhood Services Committee, Economic Development and Intergovernmental Relations Committee, Environment Committee, the Active Transportation and Infrastructure Committee, Budget and Government Efficiency Committee, Land Use and Housing Committee, and Public Safety Committee shall each have four committee members. The Rules Committee shall have five members.

2. The following appointments of the committee chair, vice chair, and committee members for each standing committee pursuant to Municipal Code section 22.0101, effective on the date of passage of this Resolution pursuant to San Diego Charter section 295(b), to serve for a term of one year, and until a successor is duly appointed and confirmed:


