A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO CONFIRMING COUNCILMEMBER  
APPOINTMENTS TO THE SPECIAL ISSUES COMMITTEE  
NAMED THE SELECT COMMITTEE ON ADDRESSING  
COST OF LIVING.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. Temporary Rule 6.11.3 of the Rules of the Council in the San Diego Municipal Code, approved by the Council, has established the temporary Special Issues Committee named the Select Committee on Addressing Cost of Living (Committee).

B. Temporary Rule 6.11.3 provides that the Council President shall nominate a Committee chair, vice chair, and Committee members, subject to confirmation by a majority vote of the Council.

C. Council President Joe LaCava has submitted nominations for those who are to serve on the Committee for one year, which may be renewed if the Council extends the Committee's work, or until successors are named and confirmed.

D. The Office of the City Attorney prepared this Resolution based on the information provided by City staff, with the understanding that this information is complete and accurate.


E. Under San Diego Charter section 280(a)(1), this resolution is not subject to veto by the Mayor because this matter is exclusively within the purview of the Council and does not affect the administrative service of the City under the control of the Mayor.

The following appointments by the Council President, to serve as chair, vice chair, and Committee members of the temporary Special Issues Committee named the Select Committee on Addressing Cost of Living, to serve for one year, which may be renewed if the Council extends the Committee's work, or until a successor is duly nominated and confirmed, are hereby confirmed: Councilmember Sean Elo-Rivera (Chair), Councilmember Henry Foster III (Vice Chair), and Councilmember Marni von Wilpert (member).
