DATE OF FINAL PASSAGE **FEB 27 2025**

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE OBLIGATIONS OF JOB ORDER CONTRACT K-20-1878-JOC-3, PIPELINE SOUTH OF I-8, TO EXTEND BEYOND FIVE YEARS TO COMPLETE SEWER AND AC WATER GROUP 794 TASK PS 1878-011 AND SEWER AND AC WATER GROUP 794 TASK PS 1878-012.

RECITALS

The Council of the City of San Diego (Council) adopts this Ordinance based on the following:

A. On February 4, 2020, the City entered into Job Order Contract K-20-1878-JOC-3 (JOC) with KTA Construction, Inc. (KTA) for pipeline work South of Interstate 8.

B. Five task orders, totaling \$9,975,297.40, were issued to KTA under the JOC. Three of the five task orders are complete, but two task orders for Sewer and AC Water Group 794 are still under construction.

C. The City now desires to extend the obligations of the JOC for an additional 12 months beyond its expiration date of February 4, 2025, to allow for the completion of Sewer and AC Water Group 794 Task PS 1878-011 and Sewer and AC Water Group 794 Task PS 1878-012.

D. The Office of the City Attorney prepared this Ordinance based on the information provided by City staff, with the understanding that this information is complete and accurate.

E. Extension of the JOC is subject to San Diego Charter section 99, which provides (subject to certain exceptions) that no contract, agreement, or obligation creating City indebtedness and extending for a period of more than five years may be authorized except by an ordinance adopted by a two-thirds majority of the Council.

ACTION ITEMS

Be it ordained by the Council of the City of San Diego:


Section 1. The obligations of Job Order Contract Pipeline South of I-8 K-20-1878-JOC-3 with KTA Construction, Inc. are authorized to extend beyond five years for an additional 12 months to February 4, 2026, to allow KTA Construction, Inc. to complete Sewer and AC Water Group 794 Task PS 1878-011 and Sewer and AC Water Group 794 Task PS 1878-012.

Section 2. The Council dispenses with a full reading of this Ordinance before its passage because a written copy of this Ordinance was made available to the Council and the public before the date of its passage.

Section 3. This Ordinance will take effect and be in force on the thirtieth day from and after its final passage.
