DATE OF FINAL PASSAGE MAR 11 2025

AN ORDINANCE AMENDING CHAPTER 2, ARTICLE 2, DIVISION 1 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 22.0101, RELATING TO RULES OF THE COUNCIL.

RECITALS

The Council of the City of San Diego (Council) adopts this Ordinance based on the following:

- A. San Diego Charter section 14 states that the Council "shall determine its own rules and order of business."
- B. The Council has adopted the Rules of the Council (Rules), which are codified in San Diego Municipal Code section 22.0101.
- C. The Council desires to amend Rule 2.2 to change the order of business of the Council on Tuesdays at 10:00 a.m. to move Ceremonial Items to occur earlier in the meeting and rename the category to "Proclamations/Ceremonial Items."
- D. This change would allow Proclamations and Ceremonial Items to be heard earlier during the Tuesday meetings, allowing for better meeting management and efficiency in conducting the City's business.
- E. The Office of the City Attorney prepared this Ordinance based on the information provided by City staff with the understanding that this information is complete and accurate.
- F. Under San Diego Charter section 280(a)(1), this Ordinance is not subject to veto by the Mayor because this matter is exclusively within the purview of the Council and does not affect the administrative service of the City under the control of the Mayor.

ACTION ITEMS

Be it ordained by the Council of the City of San Diego:

Section 1. Chapter 2, Article 2, Division 1 of the San Diego Municipal Code is amended by amending section 22.0101, Rule 2, to read as follows:
