DATE OF FINAL PASSAGE **APR 03 2025**

AN ORDINANCE OF THE COUNCIL OF THE CITY OF  
SAN DIEGO AUTHORIZING THE SECOND AMENDMENT  
TO THE CONSULTANT AGREEMENT WITH SPURLOCK  
LANDSCAPE ARCHITECTS (H166715) TO PROVIDE AS-  
NEEDED CONSULTANT SERVICES.

RECITALS

The Council of the City of San Diego (Council) adopts this Ordinance based on the following:

A. On March 23, 2017, the City and Spurlock Landscape Architects (Consultant) entered into an As-Needed Professional Services Agreement (Agreement) for five (5) years in an amount not to exceed \$3,000,000, for landscape architecture services. The First Amendment to the Agreement (First Amendment) was executed on January 27, 2022. The First Amendment extended the Agreement through March 23, 2025. Five tasks are currently under design and construction and Consultant needs additional time on the Agreement for completion of these projects.

B. If approved, the Second Amendment to the Agreement (Second Amendment), will be effective March 23, 2025, and will extend the Agreement until March 23, 2028. The Second Amendment does not add any additional funding.

C. The Office of the City Attorney prepared this Ordinance based on the information provided by City staff (including information provided by affected third parties and verified by City staff), with the understanding that this information is complete and accurate.

D. The Agreement is subject to San Diego Charter section 99, which provides (subject to certain exceptions) that no contract, agreement, or obligation creating indebtedness

and extending for a period of more than five years may be authorized except by ordinance adopted by a two-thirds majority of the Council.

ACTION ITEMS

Be it ordained by the Council of the City of San Diego:


Section 1. The Council approves the Second Amendment.

Section 2. The Mayor, or his designee, is authorized on behalf of the City to sign and deliver the Second Amendment. When signed by both parties, the Second Amendment to the Agreement, will be on file in the office of the City Clerk as Document No. OO- 21936

Section 3. The Council dispenses with a full reading of this Ordinance before its passage because a written copy of this Ordinance was made available to the Council and the public before the date of its passage.

Section 4. This Ordinance will take effect and be in force on the thirtieth day from and after its final passage.
