

ORDINANCE NUMBER O- 21949 (NEW SERIES)

DATE OF FINAL PASSAGE MAY 22 2025

AN ORDINANCE OF THE COUNCIL OF THE CITY OF  
SAN DIEGO AUTHORIZING THE FIRST AMENDMENT TO  
THE CONSULTANT AGREEMENT WITH  
PLATT/WHITELAW ARCHITECTS, INC. (H197088) TO  
PROVIDE AS-NEEDED ARCHITECTURAL  
DESIGNSERVICES.

RECITALS

The Council of the City of San Diego (Council) adopts this Ordinance based on the following:

- A. On May 1, 2020, the City and Platt/Whitelaw Architects, Inc. (Consultant) entered into a five-year Professional Services Agreement (Agreement) in an amount not to exceed \$2,500,000, for as-needed architectural design services. Four tasks are currently under design and construction and Consultant needs additional time to complete these tasks.
- B. If approved, the First Amendment to the Agreement (First Amendment) will extend the contract from 60 months to 84 months, until May 1, 2027. The First Amendment does not increase the not to exceed amount of the Agreement.
- C. The Office of the City Attorney prepared this Ordinance based on the information provided by City staff (including information provided by affected third parties and verified by City staff), with the understanding that this information is complete and accurate.
- D. The Consultant Agreement is subject to San Diego Charter section 99, which provides (subject to certain exceptions) that no contract, agreement, or obligation creating City indebtedness and extending for a period of more than five years may be authorized except by an ordinance adopted by a two-thirds majority of the Council.

ACTION ITEMS

Be it ordained by the Council of the City of San Diego:


Section 1. The Council approves the First Amendment.

Section 2. The Mayor or designee is authorized, on the City's behalf, to sign the First Amendment. When signed by both parties, the First Amendment will be placed on file in the Office of the City Clerk as Document No. OO- **21949**.

Section 3. The Council dispenses with a full reading of this Ordinance before its passage because a written copy of this Ordinance was made available to the Council and the public before the date of its passage.

Section 4. This Ordinance will take effect and be in force on the thirtieth day from and after its final passage.
