AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE OBLIGATIONS OF DESIGNBUILD CONTRACT K-21-1909-DB2-3, FOR TORREY PINES FIRE STATION PROJECT WITH LEVEL 10 CONSTRUCTION TO EXTEND TO JANUARY 4, 2028.

## **RECITALS**

The Council of the City of San Diego (Council) adopts this Ordinance based on the following:

- A. The City executed a Design-Build Contract with Level 10 Construction (Contract) for the Torrey Pines Fire Station project (Project) on June 4, 2021. The Contract was established with a duration of 900 working days for construction duration and a total contract value of \$16,500,000.
- B. As of October 2024, construction of the Project is complete, and the facility is fully operational. However, Condition 2(e) of the Coastal Development Permit (CDP) requires the Permittee to submit a landscaping monitoring report (Report), prepared by a Licensed Landscape Architect or qualified resource specialist, five years from the CDP issuance date. The Report is due July 13, 2027.
- C. This action seeks to extend the Contract to January 4, 2028, to allow for completion of the Report and close out of the Project. Once the Contract is extended a change order will be processed to add 506 working days to the construction duration and add a total amount not to exceed \$146,792 to complete the Report in compliance with CDP special condition 2(e). This amount does not cause the Project to exceed the amount previously appropriated by Council for the Project.

D. The Office of the City Attorney prepared this Ordinance based on the information provided by City staff (including information provided by affected third parties and verified by City staff), with the understanding that this information is complete and accurate.

E. The Contract is subject to San Diego Charter section 99, which provides (subject to certain exceptions) that no contract, agreement, or obligation creating a City indebtedness and extending for a period of more than five years may be authorized except by an ordinance adopted by a two-thirds majority of the Council.

## **ACTION ITEMS**

Be it ordained by the Council of the City of San Diego:

Section 1. The Council authorizes the obligations of the Contract to extend beyond five years to January 4, 2028.

Section 2. The Council dispenses with a full reading of this Ordinance before its passage because a written copy of this Ordinance was made available to the Council and the public before the date of its passage.

Section 3. This Ordinance will take effect and be in force on the thirtieth day from and after its final passage.
