

RESOLUTION NUMBER R- 315987DATE OF FINAL PASSAGE JAN 23 2025A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO CONFIRMING APPOINTMENTS TO THE  
CITY OF SAN DIEGO YOUTH COMMISSION.RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

- A. San Diego Municipal Code sections 26.1601 to 26.1605 (Municipal Code) establish a City of San Diego Youth Commission (the Commission). The Commission was created to serve as an advisory body to the Council and the Mayor on issues of interest to youth and pertaining to youth in the City of San Diego (City), facilitate the participation of youth and young adults in local government, and provide City officials an opportunity to hear and address their ideas and concerns.
- B. The Municipal Code states that the Commission will have 20 members who are residents of the City and between the ages of 14 and 25. Members shall serve without compensation, shall serve two-year terms ending on July 1, and shall serve until a successor is duly appointed and confirmed. The Municipal Code requires the Mayor appoint two members from the nominees provided by each Councilmember, for a total of 18, and two additional members chosen by the Mayor. All members appointed to the Commission shall be confirmed by Council.
- C. If any member reaches the age of 26 while serving on the Commission, the appointment of that member shall expire the following July 1.
- D. The Mayor now seeks confirmation of two appointments to the Commission.

E. The Office of the City Attorney prepared this Resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete and accurate.


