A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO EXCUSING COUNCILMEMBER CAMPILLO'S ABSENCES FROM COUNCIL AND COMMITTEE MEETINGS.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. Councilmember Raul Campillo was unable to attend Council meetings on September 30, 2024, and October 1, 2024, due to attendance at the San Diego to Singapore Trade Mission, and Council meetings on November 18 and 19, 2024, due to personal travel.

B. Councilmember Campillo was unable to attend the Public Safety Committee meeting on November 20, 2024, due to personal travel.

C. Pursuant to San Diego Charter section 12(e), the Council may excuse a Councilmember's absences from scheduled Council and Committee meetings.

D. The Office of the City Attorney prepared this Resolution based on the information provided by City staff with the understanding that this information is complete and accurate.

E. Under San Diego Charter section 280(a)(1), this Resolution is not subject to veto by the Mayor because this matter is exclusively within the Council's purview and does not affect the administrative service of the City under the Mayor's control.


ACTION ITEMS
