A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO CONFIRMING AN APPOINTMENT AND
REAPPOINTMENTS TO THE COMMISSION FOR ARTS AND
CULTURE WAIVER OF COUNCIL POLICY 000-13.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. The Commission for Arts and Culture (Commission) is established in San Diego Municipal Code sections 26.0701 through 26.0728 (Municipal Code) to advise the Mayor and Council on promoting, encouraging, and increasing support for the region's artistic and cultural assets, integrating arts and culture into community life, and showcasing San Diego as an international tourist destination.

B. The Municipal Code provides that the Commission shall consist of 15 members appointed by the Mayor and confirmed by the Council. Of the 15 members: (1) the Mayor shall appoint six members directly; and (2) the Mayor shall appoint the remaining nine members, one each from a list of three nominations submitted by each Councilmember.

C. The Municipal Code provides that members shall serve two-year staggered terms; each member shall serve until a successor is duly appointed and confirmed; and all terms must expire on August 31.

D. Members shall be persons that represent the following: individual arts and culture patrons, artists, educators, the business and professional community, those with professional qualifications and experience or knowledge of a particular arts and culture field, and the general public.

E. The Mayor now seeks Council confirmation of a reappointment to the Commission.

F. The Office of the City Attorney prepared this Resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete and accurate.

1. The following appointments and reappointments by the Mayor to serve as members of the Commission for Arts and Culture, for terms expiring as indicated below, are made and hereby confirmed:
