

RESOLUTION NUMBER R- 316009DATE OF FINAL PASSAGE JAN 28 2025A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AMENDING THE 2025 LEGISLATIVE
CALENDAR.RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. Each year, the Council adopts a schedule of meetings for the calendar year for the Council and its Standing Committees, commonly referred to as the legislative calendar.

B. In San Diego Resolution R-315876 (Nov. 12, 2024), the Council adopted the 2025 Legislative Calendar along with the Fiscal Year 2026 Budget Development and Fiscal Year 2025 Budget Monitoring Key Dates, which is available on the City Clerk's website.

C. In San Diego Resolution R-315969 (Dec. 17, 2024), the Council added Temporary Rule 6.11.3 to the Rules of Council to create a special issues committee named the Select Committee on Addressing Cost of Living (Select Committee).

D. The Council also authorized the Select Committee to meet beginning January 8, 2025 through December 19, 2025, unless the objectives for which it was created are not complete, in which case the Council may extend the Committee's work for up to an additional two years.

E. San Diego Municipal Code section 22.0101 allows the Council to adopt a resolution that changes, when necessary, the time and place of a regular meeting and sets forth the circumstances necessitating the change.

F. The Council President proposes to amend the 2025 Legislative Calendar with changes to add new dates for the Select Committee.

- G. The requested amendments to the 2025 Legislative Calendar will:
1. Add a Select Committee on Addressing Cost of Living meeting on Thursday, February 27, 2025, at 9:00 a.m.
 2. Add a Select Committee on Addressing Cost of Living on Wednesday, June 4, 2025, at 9:00 a.m.
 3. Add a Select Committee on Addressing Cost of Living on Thursday, September 25, 2025, at 9:00 a.m.
 4. Add a Select Committee on Addressing Cost of Living on Friday, November 14, 2025, at 9:00 a.m.

H. The Office of the City Attorney prepared this Resolution based on the information provided by City staff with the understanding that this information is complete and accurate.

I. Under San Diego Charter section 280(a)(1), this resolution is not subject to veto by the Mayor because this matter is exclusively within the purview of the Council and does not affect the administrative service of the City under the control of the Mayor.


ACTION ITEMS
