The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. On October 10, 2022, QBE Insurance Corporation filed a claim against the City of San Diego alleging property damage arising from a weakened portion of asphalt on Taxiway Hotel of the Montgomery Gibbs Executive Airport (Claim); and

B. In closed session on December 16, 2024, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7, 8 and 9; Nays, None; and Absent, None, approved the Settlement for an amount consistent with the amounts set forth below.


ACTION ITEMS

1. The Mayor or his designee is authorized to pay the sum of \$265,123.09 from Public Liability Fund No. 720045 in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorneys' fees, against the City, its agents, and employees, arising from the Claim.

2. The Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$265,123.09 from the Public Liability Fund No. 720045, for the purpose of settling this Claim.
