DATE OF FINAL PASSAGE **FEB 27 2025**

A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING ACCEPTANCE OF RELINQUISHMENT FROM THE CALIFORNIA DEPARTMENT OF TRANSPORTATION OF APPROXIMATELY 22,000 SQUARE FEET OF LAND LOCATED BETWEEN THE INTERSTATE 5 FREEWAY AND SANTA FE STREET, BENEATH THE ROSE CREEK BIKEWAY.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. In 2021, the San Diego Association of Governments (SANDAG), under that certain Cooperative Agreement for Project Review Procedures between SANDAG and the City of San Diego (City), filed in the Office of the City Clerk on August 17, 2009, as Document No. C-15015 (Cooperative Agreement), completed the Rose Creek Bikeway (Bikeway), located in the eastern Pacific Beach community of the City, on certain real property owned by the California Department of Transportation (Caltrans), located between the Interstate 5 Freeway and Santa Fe Street (Property).

B. Under California Streets and Highways Code Section 73 (Section 73), Caltrans may relinquish to the City any nonmotorized transportation facility constructed as part of a state highway project located within the territorial limits of the City if the Council adopts a resolution consenting to the relinquishment.

C. Caltrans requested that the City accept relinquishment of the Property under Section 73 by Council resolution authorizing the Mayor or designee to send the proposed Letter of Relinquishment Acceptance (Letter), included in the docket materials accompanying this Resolution, to Caltrans.

D. The Property value determined by the City's Principal Appraiser is \$25,300 based on market data.


E. The Office of the City Attorney prepared this Resolution based on the information provided by City staff, with the understanding that this information is complete and accurate.
