A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT OF
MARGUERITE HERRICK AND THE CITY OF SAN DIEGO

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. On August 23, 2023, Marguerite Herrick filed suit against the City of San Diego alleging personal injuries arising from a trip and fall incident that occurred on February 24, 2023, on cracked and depressed concrete surrounding a water meter box on the sidewalk located at 13149 Trail Dust Avenue. The lawsuit is entitled *Marguerite Herrick v. City of San Diego*, San Diego Superior Court Case No. 37-2023-00036450-CU-PO-CTL (Litigation).

B. In closed session on December 16, 2024, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 5, 6, 7, 8, and 9; Nays, None; Absent, None, approved the settlement of the Litigation for an amount consistent with the amounts set forth below.


ACTION ITEMS

Be it resolved by the Council of the City of San Diego:

1. The Mayor or his designee is authorized to pay the sum of \$90,000.00 from Water Utility Operating Fund No. 700011 in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorneys' fees against the City, its agents, and employees, arising from the Litigation.

2. The Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$90,000.00 from the Water Utility Operating Fund No. 700011, for the purpose of settling the Litigation.
