A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE ESTABLISHMENT OF NEW RATES AND FEES AND ADJUSTMENTS TO EXISTING RATES AND FEES FOR INCLUSION IN THE RATE BOOK OF CITY FEES AND CHARGES MAINTAINED BY THE DEPARTMENT OF FINANCE AND MADE AVAILABLE THROUGH A LINK ON THE CITY CLERK'S PUBLIC WEBSITE.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. Under Council Policy 100-05, general fund departments are required to conduct comprehensive user fee studies every three to five years, and approved fees are published in the City's user fee rate book (Rate Book) maintained by the Department of Finance and made available to the public through a link posted on the City Clerk's public website.

B. These fee studies ensure City departments identify and recover all reasonable and allowable costs incurred in providing government services.

C. Each general fund department requesting user fee adjustments and additions for Fiscal Year (FY) 2026 obtained a legal opinion on its fee proposals from the Office of the City Attorney in light of Proposition 26.

D. Approved by the voters in 2010, Proposition 26 amended articles XIII A and XIII C of the California Constitution to provide that a levy, charge, or exaction of any kind imposed, increased, or extended by a local government is a tax unless an exception applies.

E. Exceptions to Proposition 26 include user fees; government service or product fees; regulatory fees; government property use or entrance fees; fines and penalties imposed by a court or local government; property development impact fees; and assessments and property-related fees governed by Proposition 218.

F. Each Proposition 26 exception involves its own legal standard for determining the amount of a legally permissible fee.

G. User fees and regulatory costs in support of the proposed user fee adjustments and additions for FY 2026 may not exceed the reasonable costs of providing a service, product, or regulation which includes all reasonable direct and indirect expenses incurred by the City.

H. Depending on the particular type of fee and individual department activities, staff for each City department calculated proposed FY 2026 user fee adjustments and additions using the comprehensive Citywide method developed by Department of Finance staff.

I. City staff reports from each department substantiate the validity of the proposed user fees and regulatory costs for FY 2026 by explaining the link between the cost and the service, product, or regulation.

J. The Department of Finance gave a presentation to the Budget and Government Efficiency Committee (Committee) on February 5, 2025 wherein the department requested approval of proposed FY 2026 user fee adjustments and additions for thirteen general fund departments and nine non-general fund departments including, but not limited to, the City Attorney, City Clerk, City Planning, City Treasurer, Compliance, Development Services, Economic Development, Engineering and Capital Projects, Environmental Services, Fire-Rescue, Library, Personnel, Police, Public Utilities, Risk Management, Special Events and Filming, and Transportation.

K. The Department of Finance and each of the departments mentioned above also provided to the Committee a detailed report explaining their respective proposed FY 2026 user fees and adjustments and the cost recovery calculations for same.

L. After considering the presentations made, the reports and materials presented, and engaging in discussion regarding the proposed FY 2026 fee adjustments and additions, the Committee forwarded the proposed FY 2026 user fees to the City Council for consideration.

M. The Office of the City Attorney has drafted this resolution based on the information provided by City staff, with the understanding that this information is complete, true, and accurate.

ACTION ITEMS

Based on the Recitals set forth above, the Council resolves as follows:

1. The following FY 2026 fee additions and adjustments are adopted for the purpose of recovering costs incurred by the City of San Diego in providing services, goods, or regulation, or as otherwise permitted under articles XIII A and XIII C of the California Constitution:

(1) The Office of the City Treasurer's Collection Referral Fee of \$25 or 10%, whichever is greater up to max \$1,000 Per Incident has Increased to \$40 or 10%, whichever is greater up to max \$5,000 Per Incident.



Personnel related costs shall be based on Council-approved general salary increases and increases to fringe benefits. Non-personnel costs as well as Category 3 fees shall be based on increases to the regional Consumer Price Index.
