A RESOLUTION OF THE COUNCIL OF THE CITY OF

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. Plaintiff Isabella Franco (Plaintiff) alleges she suffered personal injuries because of a car accident due to a missing stop sign at the intersection of Home Avenue and the exit ramp of the eastbound SR-94 freeway. The lawsuit is entitled *Isabella Araceli Franco v. City of San Diego*, San Diego Superior Court Case No. 37-2023-00044352-CU-PA-CTL (Litigation).

B. In closed session on January 27, 2025, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 4, 6, 7, 8, and 9; Nays, District 5; Absent, None, approved the settlement of the Litigation for an amount consistent with the amount set forth below.


ACTION ITEMS

Be it resolved by the Council of the City of San Diego:

1. The sum of \$2,000,000.00 to be paid from Public Liability Fund No. 720045 in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorneys' fees, against the City, its agents, and employees, arising from the Litigation.

2. Authorizes the Chief Financial Officer to appropriate and expend an amount not to exceed \$2,000,000.00 from the Public Liability Fund No. 720045, for the purpose of settling the Litigation.
