RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

- A. On November 30, 2022, Charlene Pryor (Plaintiff) filed a lawsuit against the City of San Diego (City) alleging damages from a trip and fall on a sidewalk entitled *Charlene Pryor* v. City of San Diego, San Diego Superior Court Case No. 37-2022-00048536-CU-PO-CTL (Litigation).
- B. In closed session on January 13, 2025, the City Council, by the following votes: Yeas, 1, 2, 3, 4, 5, 6, 7, 8, and 9; Nays, None; and Absent, None, authorized settlement of the Litigation for an amount consistent with the amounts set forth below and in accordance with such other terms more fully set forth in the Settlement and Release Agreement.

ACTION ITEMS

Be it resolved by the Council of the City of San Diego:

1. Authorizes the Mayor or his designee to pay the sum of \$110,000.00 from Public Liability Fund No. 720045 in settlement of each and every claim for damages, interest, costs; and fees of any type, including attorneys' fees, against the City, its agents, and employees, arising from the Litigation.
