A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ADOPTING AN AMENDED VERSION OF CITY OF SAN DIEGO COUNCIL POLICY 000-17, TITLED "FURNISHING BACK-UP MATERIAL FOR COUNCIL DOCKET."

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. City of San Diego Council Policy 000-17, titled "Furnishing Back-Up Material for Council Docket" (CP 000-17), describes the procedures for providing Council docket back-up materials to the public.

B. CP 000-17 was last updated on December 6, 2016, to add references to electronic distribution and Ralph M. Brown Act (Brown Act) requirements.

C. The proposed amendments to CP 000-17 include the several ways members of the public may access the Council docket back-up materials in accordance with the Brown Act and a printed copy for a fee identified in the adopted User Fee Schedule. Interested members of the public may request the Office of the City Clerk email a link to the Council docket back-up materials, visit the City Clerk's page on the City's website to view, download, or print the back-up materials, or request a printed copy of the material to be mailed or picked up at the Office of the City Clerk.


D. The Office of the City Attorney prepared this Resolution based on the information provided by City and Council staff, with the understanding that this information is complete and accurate.
