A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO REPEALING CITY OF SAN DIEGO COUNCIL  
POLICY 000-19, TITLED "LEGISLATIVE POLICY  
GUIDELINES – 2000-2001".

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. City of San Diego Council Policy 000-19, titled "Legislative Policy Guidelines – 2000-2001" (CP 000-19), describes the process for evaluating proposed legislation at the State and Federal level and communicating the City of San Diego's (City) positions on legislation.

B. CP 000-19's stated purpose is to provide policy direction to City Departments and the Intergovernmental Relations Department (IRD) in evaluating proposed legislation at the State and Federal level and provide a timely response of the City's support or opposition to the legislation.

C. CP 000-19 was last updated on October 2, 2000.

D. Ordinance O-21002 (Oct. 26, 2018) amended San Diego Municipal Code section 22.1901 to change the name of the IRD to the Government Affairs Department and remove the requirement for the City's legislative program by a Council Policy.

E. CP 000-19 is unnecessary because its function is now served by the legislative platform, which is governed by Municipal Code section 22.1901 and approved by Council annually.


F. The Office of the City Attorney prepared this Resolution based on the information provided by Council staff, with the understanding that this information is complete and accurate.
