A RESOLUTION OF THE COUNCIL OF THE CITY  
OF SAN DIEGO CONFIRMING APPOINTMENTS  
TO THE INDEPENDENT RATES OVERSIGHT  
COMMITTEE.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. San Diego Municipal Code sections 26.2001 through 26.2003 (Municipal Code) established the Independent Rates Oversight Committee (IROC) to advise the Mayor and Council on policy issues relating to the oversight of the City of San Diego's (City) public utilities department operations.

B. The Municipal Code provides that the IROC shall consist of eleven members appointed by the Mayor and confirmed by the Council. Members shall serve staggered four-year terms, each member shall serve until a successor is duly appointed and confirmed, and all terms must expire on May 1. The Municipal Code also provides that a majority of IROC members shall be City residents.

C. The IROC shall include at least one member from each of the following four ratepayer classes: single-family residential, multifamily residential, commercial and industrial, and temporary irrigation and construction.

D. A majority of the members shall possess expertise in one or more of the following areas: accounting, auditing, engineering, biology or environmental science, finance or municipal finance, law, and construction management.

E. The Office of the City Attorney prepared this Resolution based on the information provided by City staff, including information provided by affected third parties and verified by City staff, with the understanding that this information is complete and accurate.
