A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO SUSPENDING THE RULES OF COUNCIL

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. On January 9, 2024, Council considered All Peoples Church’s application for permits and approvals to construct a church/sanctuary building and a two-level parking garage and surface parking areas, including (1) General Plan/Navajo Community Plan Amendment No. 2292367; (2) Site Development Permit (SDP) No. 2292338 and Planned Development Permit (PDP) No. 2292339; (3) Tentative Map No. 2490918; (4) approval of Easement Vacation (including revestment of rights) No. 2292340; and (5) certification of environmental impact report (EIR) No. 636444/SCH No. 2021100394, including the adoption of the mitigation and monitoring and reporting program and findings (Project). At the conclusion of the hearing, Council voted 6-2 not to approve the Project.

B. On March 25, 2024, All Peoples Church filed an action against the City of San Diego (City) in United States District Court, *All Peoples Church v. City of San Diego*, 24-cv-0562-TWR-MSB, alleging that the denial of the Project violated the Religious Land Use and Institutionalized Person Act (RLUIPA), All Peoples Church’s right to free exercise of religion, and the right to free speech and assembly under the First Amendment of the United States Constitution, and the California Constitution.

C. On June 10, 2024, Council agreed to docket a request to hear a motion for

reconsideration of the Project pursuant to the City's procedure for reconsideration as codified in the San Diego Municipal Code section 22.0101, Rule 2.12, Rules of Council.

D. A request to reconsider a matter at any time after the meeting at which the matter was voted upon must be re-docketed as a Special Order of Business.

E. Once the request to reconsider is docketed and in order to reconsider a matter that included a noticed hearing as described in San Diego Municipal Code section 22.0101, Rule 2.4.4, Rules of Council, the Council must first suspend these Rules of Council by a two-thirds vote of the Councilmembers before it may vote on the motion to reconsider.

F. On March 11, 2025, Council considered the request to suspend the Rules of Council under San Diego Municipal Code section 22.0101, Rule 2.12.2.

G. The Office of the City Attorney prepared this Resolution based on the information provided by City staff, with the understanding that this information is complete and accurate.


H. Under Charter Section 280(a)(2), this Resolution is not subject to veto by the Mayor because this matter requires the Council to act as a quasi-judicial body, a public hearing was required by law implicating due process rights of individuals affected by the decision, and the Council was required by law to consider evidence at the hearing and to make legal findings based on the evidence presented.

ACTION ITEMS

Based on the Recitals set forth above, the Council resolves as follows:

1. The Council hereby suspends the Rules of the Council, section 22.0101 of the San Diego Municipal Code by a vote of two-thirds of the Councilmembers.
