A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO APPROVING THE SETTLEMENT BETWEEN
CHARLOTTE ESTRADA-PEPPER AND THE CITY OF
SAN DIEGO.

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

A. On January 22, 2024, Plaintiff Charlotte Estrada-Pepper by and through her Guardian ad Litem, Juley Tillman filed suit in San Diego Superior Court against the City of San Diego and an officer employed by the City. The suit is entitled *Charlotte Estrada-Pepper v. City of San Diego, et al.*, San Diego Superior Court Case No. 37-2019-00039360-CU-PA-CTL (Litigation).

B. In closed session on February 10, 2025, the San Diego City Council, by the following votes: Yeas, Districts 3, 4, 6, 8, and 9; Nays, None; and Absent, District 1, 2, 5, and 7; approved settlement of the Litigation for an amount consistent with the amounts set forth below and pursuant to such other terms more fully set forth in the Settlement and Release Agreement.


ACTION ITEMS

Be it resolved by the Council of the City of San Diego:

1. Authorizes the Mayor or his designee to pay the sum of 85,000.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the Litigation.

2. Authorizes the Chief Financial Officer to appropriate and expend an amount not to exceed \$85,000.00 from Public Liability Fund No. 720045, for the purpose of settling this Litigation.
