## **RECITALS**

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

- A. On November 13, 2019, Plaintiffs, Kurt Heitmann and Bita Heitman filed suit in San Diego Superior Court against the City of San Diego. The suit is entitled *Kurt Heitmann et al.* v. City of San Diego, et al., San Diego Superior Court Case No. 37-2019-00060502-CU-PO-CTL and was consolidated into Miguel Angel Pizarro, et al. v. City of San Diego, et al. San Diego Superior Court Case No. 37-2019-00039360-CU-PA-CTL (Litigation).
- B. In closed session on December 11, 2023, the City Council, by the following votes: Yeas, Districts 1, 2, 3, 5, 6, 7, 8 and 9; Nays, None; and Absent, Districts 4; authorized settlement of the Litigation for in exchange for revisions to the applicable San Diego Police Department Procedure and an amount consistent with the amounts set forth below and pursuant to such other terms more fully set forth in the Settlement and Release Agreement.

## **ACTION ITEMS**

Be it resolved by the Council of the City of San Diego:

1. Authorizes the Mayor or his designee to pay the sum of \$500,000.00 from Public Liability Fund No. 720045, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorney fees, against City of San Diego, its agents and employees, arising from the Litigation.
