A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE SETTLEMENT BETWEEN MONALI PATEL, HEMANT CHHATRALA, REKHA PATEL, SARJAN PATEL, AND THE CITY OF SAN DIEGO

RECITALS

The Council of the City of San Diego (Council) adopts this Resolution based on the following:

- A. Plaintiffs Monali Patel, Hemant Chhatrala, Rekha Patel, and Sarjan Patel filed suit against the City of San Diego alleging property damage due to a sewage backup spill in their home that occurred on September 5, 2022. The suit is entitled *Sarjan Patel*, et al. v. City of San Diego, San Diego Superior Court Case No. 37-2023-00024205-CU-EI-CTL (Litigation).
- B. In closed session on December 16, 2024, the San Diego City Council, by the following votes: Yeas, Districts 1, 3, 4, 5, 6, 7, 8, and 9; Nays, none; Absent 2, approved the settlement of the Litigation for an amount consistent with the amounts set forth below and pursuant to such other terms more fully set forth in the Settlement Agreement.

ACTION ITEMS

Be it resolved by the Council of the City of San Diego:

1. Authorizes the Mayor or his designee to pay the sum of \$250,000.00 from WMuni Sewer Revenue Fund No. 700000, in settlement of each and every claim for damages, interest, costs, and fees of any type, including attorneys' fees, against City of San Diego, its agents and employees, arising from the Litigation.

2.	Authorizes the Chief Financia	al Officer to appropriate and expend an amount not
to exceed S	\$250,000.00 from Muni Sewer Re	venue Fund No. 700000 for the purpose of settling
